Top 39 in this class, plus top five from Sturgis, will qualify for the main which starts@ 10am.on Sunday. Bike must have one working brake and tether kill switch. You may run 3 or 4-cylinder engines up to 600cc, 1 or 2 cylinder engines up to 700cc, and 2-cylinder pushrod engines up to 750cc. Nitro, nitrous, blowers, unlimited wheelbases, steel, 2 or 4-strokes, and rubber or steel paddled tires, including steel bolts or steel paddles are all okay, (with safety rear fender). ALL entries must be postmarked by Sept 9. You MUST be an annual NAHA member (\$50) to run in this class. There is NO onsite registration for this class! You MUST enter by Sept 9!</p>
